OUR INDEPENDENCE MATTERS

The National Commission on Correctional Health Care has no membership or dues. NCCHC does not require any affiliation to be considered for accreditation, certification, or employment as a consultant or surveyor, or to serve on committees or the board of representatives.

NCCHC is impartial, unbiased, and dedicated to recognizing and fostering improvements in correctional health care.

MISSION STATEMENT

The mission of the National Commission on Correctional Health Care is to improve the quality of health care in jails, prisons, and juvenile confinement facilities.

NCCHC ORIGINS

NCCHC's origins date to the early 1970s, when an American Medical Association study of jails found inadequate, disorganized health services and a lack of national standards. In collaboration with other organizations, the AMA established a program that in 1983 became NCCHC, an independent, nonprofit 501(c)(3) organization whose early mission was to evaluate and develop policy and programs for a field clearly in need of assistance.

NCCHC TODAY

Today, NCCHC's leadership is recognized internationally. To help correctional health care systems provide efficient, high-quality care, we offer a broad array of services and resources. We establish standards for health services in correctional facilities, operate a voluntary accreditation program for institutions that meet those standards, produce resource publications and tools, conduct educational conferences, nonprofit and offer certification for correctional health professionals.

NCCHC is supported by the major national organizations representing the fields of health, mental health, law, and corrections. Each supporting organization has named a liaison to the NCCHC board of representatives to create a robust, multidisciplinary structure that reflects the complexities of correctional health care.

THE NCCHC STANDARDS: A FRAMEWORK FOR QUALITY

When it comes to delivering quality care in correctional settings, the NCCHC *Standards* provide the framework to ensure that systems, policies, and procedures are in place to produce the best outcomes in the most cost-efficient and effective manner.

Developed by leading experts in the fields of health, mental health, law, and corrections, the *Standards* are our recommendations for managing the delivery of health services. These authoritative manuals have guided the field in continuously improving care for incarcerated individuals, strengthening organizational effectiveness, and reducing the risk of adverse legal judgments. The *Standards* are also the foundation of NCCHC's accreditation program.

All five editions — for jails, prisons, juvenile facilities, mental health services, and opioid treatment programs — have a strong focus on quality and outcomes and offer flexibility in how to achieve results. Only NCCHC and NCCHC Resources are qualified and authorized to assess compliance with NCCHC Standards.

NCCHC Standards are widely accepted by the courts and are the benchmark for an acceptable level of health care in corrections.

After nearly 40 years of litigation, a U.S. District Court judge ordered an end to a class action case stating that compliance with NCCHC standards constitutes "powerful evidence" of compliance with the Eighth Amendment prohibiting cruel and unusual punishment. In finding no constitutional violation in the health care provided to incarcerated individuals in the case, the judge wrote that NCCHC accreditation and compliance tied to NCCHC standards, while not determinative, "constitute substantial evidence of adequate medical care."

For nearly 50 years, NCCHC has set the standards for quality constitutional care and awarded accreditation to facilities that demonstrate their commitment to those standards.

Accreditation from NCCHC validates a correctional facility's commitment to quality care and quality improvement in its clinical, administrative, and legal obligations.

NCCHC is the first and only accrediting body dedicated exclusively to health care in the nation's jails, prisons, and juvenile facilities, and its accreditation program is the only one overseen by correctional health care experts.

Accreditation is an objective, third-party review in which NCCHC, an independent, nonprofit organization, recognizes correctional facilities that meet its nationally recognized standards, the benchmark for quality correctional health care services and the most comprehensive correctional health standards.

Accreditation has now been proven in a rigorous third-party study to have significant benefits without, in many cases, requiring additional staff or resources.

MORE BENEFITS

Accredited facilities report that accreditation:

- Promotes and documents an efficient, wellmanaged system of health care delivery with feedback from knowledgeable correctional health professionals
- Validates with objective criteria the areas in which the health care staff is doing well and areas for improvement
- Educates and trains staff on NCCHC standards, with the benefit of introducing new efficiencies and uniform practices
- Recognizes staff contributions and excellence, improves morale, and aids recruitment and retention
- Helps obtain community support and provides justification for budget requests

WHAT SETS US APART?

- Survey teams are customized to the facility's programs (e.g., mental health surveyors for extensive mental health programs, dentist surveyors for facilities with on-site dental care).
- We can survey one facility at a time or the entire system in the span of a week, depending on your needs.
- Survey teams have specific expertise in correctional health care, and each team includes a physician.
- NCCHC accreditation staff and surveyors have worked in corrections – we understand how to implement standards because we've used them and can offer pre- and post-survey support.

A STEP-BY-STEP GUIDE TO NCCHC ACCREDITATION

STEP 1 BECOME KNOWLEDGEABLE ABOUT THE STANDARDS

 Read the Standards to become familiar with them and how they apply to your setting or program.

STEP 2 APPLY AND SUBMIT THE NCCHC ACCREDITATION APPLICATION

• Complete the full application at MyNCCHC.org.

STEP 3 SUBMIT SURVEY FEES

 NCCHC will send an invoice to your facility once your application is approved.

STEP 4 CONDUCT A SELF-ASSESS-MENT AND PREPARE FOR THE SURVEY

- Use the self-assessment tool and the Survey Preparation Guide (sent to you after application).
- · Evaluate your compliance with the Standards.

STEP 5 SCHEDULE THE SURVEY

- NCCHC will schedule your survey when you are ready.
 - Initial surveys require 10-12 months of documentation.
 - Reaccreditation requires 36 months of documentation.


STEP 6 NCCHC CONDUCTS THE SURVEY

- The survey team will work collaboratively with you to determine compliance with the Standards through observation of the health care delivery services. Each survey includes:
 - An entrance conference
 - Review of health records and other documents, including policies and procedures
 - Facility tour
 - Structured interviews with health staff, administrators, custody staff, other personnel, and incarcerated individuals
 - An exit conference to provide preliminary feedback and answer questions



NCCHC SURVEYORS

NCCHC survey teams are made up of professionally certified and experienced physicians, nurses, health services administrators, and corrections professionals who understand correctional health care operations. They review patient health records as well as policies and procedures; interview health staff, correctional officers, and incarcerated individuals; and tour the facility. Finally, they conduct an exit conference to discuss their preliminary findings.



AFTER THE SURVEY

- The lead surveyor submits the report to the accreditation committee.
- The accreditation committee carefully evaluates the findings for compliance with the Standards and determines the accreditation decision.
- NCCHC will send a comprehensive survey report to the responsible official and health services administrator within two weeks of the committee meeting.
- · Facilities will be asked to provide corrective action for standards found to be out of compliance.


ONGOING ACCREDITATION

- · Each year the facility will submit an Annual Maintenance Report with updates.
- · As part of the accreditation cycle, a survey team will conduct a visit every three years.

PROFESSIONAL CERTIFICATION



Basic certification is available for all professionals working in correctional health care, including administrative, correctional, and support staff. It is a stepping-stone (and an eligibility requirement) toward advanced and specialty certifications.

CCHP CERTIFICATION IN 4 EASY STEPS

- 1. Submit initial application (online form and fee); you will then receive the candidate handbook and instructions for completing the application.
- 2. Complete application (provide resume and license).
- 3. Submit registration to take the exam (NCCHC conference, test center, or online).
- 4. Study for and take the exam; you will receive results within two weeks.

CCHP EXAM PREPARATION TIPS

The CCHP exam is based on the content of NCCHC's *Standards*, so learning the standards is critical to passing the exam. Successful candidates often undertake study sessions, either alone or in a group. Sample test questions provide an idea of what to expect (see **ncchc.org/sample-questions**).

RECERTIFICATION

Certification is valid for one year. All CCHPs must apply for continuing certification annually. Continuing certification requires participation in 18 hours of continuing education per year, at least six of which are specific to correctional health care. Documentation of these activities need not be submitted, but we highly recommend that you maintain documentation of your continuing education activities.



ADVANCED CERTIFICATION

The CCHP-Advanced program recognizes CCHPs who have demonstrated excellence, commitment, and contribution to the field of correctional health care and their own discipline or profession. Advanced certification requires at least three years of participation in the certification program and demonstration of extensive experience in and knowledge of correctional health services delivery.

SPECIALTY CERTIFICATION

Correctional health professionals face unique challenges. They must provide effective, efficient care to a high-acuity population while facing strict security regulations, crowded facilities, and myriad legal and public health concerns. Specialty certification provides validation of a commitment to maintain the knowledge necessary to provide care to incarcerated patients. Specialty exams measure mastery of the standards, with focus on the roles and responsibilities germane to the discipline.
