



# COVID-19 IN CORRECTIONAL FACILITIES

## HIGHLIGHTS

- Facilities surveyed to date include **295 jails and prisons** from **42 states**.
- Among facilities surveyed to date, there have been **66 reported cases** and **0 reported deaths** due to COVID-19.
- Among facilities surveyed to date, 45% are screening current inmates, 93% are screening new intakes, and 78% are screening staff.
- Among facilities surveyed to date, 97% have specific protocols and procedures for managing COVID-19 and 63% have access to lab testing for COVID-19.
